The Kidney Foundation of Canada is the leading advocate for equitable access to kidney care across Canada. This role will support the Programs and Public Policy department in taking action to bring about changes to government policies relating to all areas of concern to the kidney community, including access to medications, the financial burden of kidney disease, organ donation, and others.



## What You Will Be Doing:

- Developing key health policy initiatives, projects and assignments and providing position recommendations to the Leadership Team.
- Providing specific advice on key initiatives, projects and assignments related to access to treatments in Canada.
- Analyzing health policy-related issues relevant to the work of the organization including researching and synthesizing information, identifying policy options, preparing policy documents and evaluating potential impacts of policy decisions.
- Overseeing research design, collection and analysis of data (quantitative/qualitative), and interpretation and dissemination of results that impacts public policy for the organization.
- Overseeing/leading scans of issues, legislation and development that impacts the policy development function of the organization.
- Drafting impactful reports, presentations, papers, government submissions and briefing notes, etc., articulating the organization's position.
- Working in collaboration with internal and external stakeholders (healthcare professionals, academics, elected officials, senior government representatives, and industry) to disseminate the organization's position, build consensus, promote change and call to action.
- Representing the organization at meetings with external stakeholders as required.
- On behalf of the organization, speaking at conferences and workshops, disseminating information, and promoting the organization's policy position.

## Qualifications, Skills and Experience Needed:

- Master's degree from a recognized university in health sciences, economics or social sciences or an equivalent combination of education, training and experience.
- Three years of policy analysis experience in a relevant field.
- Exceptional verbal and written communication skills (English mandatory, English/French bilingual an asset)
- Demonstrated experience in patient engagement initiatives.
- Ability to research, interpret and disseminate quantitative/qualitative literature and identify potential implications for policy and practice pertinent to health .
- Demonstrated success working within interdisciplinary teams and in partnerships with groups such as policymakers, researchers, advocates and service providers with excellent relationship-building skills.
- Knowledge of and experience with project management.
- Ability to draft meaningful policies and recommendations and write impactful narratives from data and supporting evidence.



- Not-for-Profit experience preferred.
- Demonstrated ability to research, study and interpret policy information options and develop policy options/proposals.
- The ability to support the design and implementation of complex policy initiatives and to access and synthesize information on various topics.
- Consensus-building, consultation and negotiations skills.
- Understanding of health policy issues and health policy development processes through a history of involvement in/or knowledge of government.
- Ability to conceptualize easily, learn quickly and independently, exercise good judgment, and demonstrate initiative.
- Superior report-writing and presentation skills.
- Ability to translate knowledge and expertise for a variety of audiences.
- Ability to participate and contribute effectively as part of a team.
- Sensitive to issues of health equality and ability to analyze how policy options will differentially impact the diverse communities living in Canada.
